- Gathering, gathering—in weekly reflection and fellowship; at the delightful, first-ever Family Retreat; as part of the glorious Perfection Free Singing series outside on the terrace under the beautiful autumn trees; with all ages, learning together at Kid's Kamp; laughing together at the hilarious Entertainment Night, and during our beautiful Lessons and Carols service, to name just a few

Lay Leadership Report

It has been a privilege and a joy to serve as president of our Coordinating Council this year. Our coordinating council is an eclectic collection of amazing individuals who have covenanted to lead our precious congregation. The council regularly works through challenging issues with honesty, openness, and humility to produce effective consensus solutions.

2022 was our first full calendar year of operation. We have all been very busy doing necessary "structural" firsts.

Our mission is well understood in broad terms, but we need to work on refining it. In 2022, we sort of "did everything". A more refined mission definition will allow us to be more specific in choosing what to do, or not do.

After our first full calendar-year operation, we now have a firm basis for estimating giving and operating expenses. A review of the proposed budget shows that the council is recommending a budget with a \$44,000 deficit. Following is an overview of the assessment and strategy discussed by the council. It is very important that members of the congregation understand this and take it into consideration as part of approving the proposed budget.

Assessment and Strategy

The coordinating council reviewed the budget numbers and worked diligently to discern and make decisions on behalf of the congregation. Three key assertions guided much of the decision making:

Assertion: Ministry – It's NOT about number of members or money

Council asserts that our congregation wants to serve and would not be in favor of making ministry decisions based on the likelihood of increasing membership or raising money.

On the other hand, we endeavor to carry out our ministry in a way that invites others, and it is reasonable to expect that membership would increase as a result of others joining in our ministry.

Assertion: Sustainability – It's ALL about number of members and money

Council recognizes that we will not be financially sustainable if we continue to carry a large deficit. We believe that we must consider sustainability but that it cannot be done at the cost of abandoning ministry.

It would be fair to say that the council concluded sustainability is a goal but not a requirement. We choose to perform our best ministry as long as possible, but we do not choose to perform a less effective ministry solely to survive for a longer time.

Assertion: Cash Assets - "Seed Money" to sustain us until we can sustain ourselves

St. Pauls' cash assets make it possible for us to operate at a deficit while we become established. The consensus St. Paul's opinion is that those assets are for ministry, and that we should only use it for ourselves if we believe that it will produce more effective ministry than donating it to some other cause.

Recommendations

- Fully fund desired ministries, but be intentional about cost effectiveness.
- Make details of operating costs, deficits, and strategy very clear to the congregation. Encourage reconsideration of pledges considering this information
- Work intentionally to clearly discern and refine our mission definition and direction
- Embark on a nine-year plan, carefully monitoring membership and giving progress reports, and recommend course corrections as needed

Church Life Team

Church Life is a group of nine people (including our pastor) who meet monthly to plan worship experiences, all-church events, and drives for the Spirit of Peace congregation. Two members rotated off in 2022- Jan Guetschow and Linda McGee. Thank-you for your service!

The current members are: Laura Eggert, Deb Flynn, Kay Smith, Kris Jacobson, Deb and Randy Sund, Deb Mathison, Janet Labrecque, and Pastor Zoe.

In 2022, we provided sermon or season theme-related decor for the sanctuary, publicity for services, communion, coffee hour, 2 potlucks, and a kid's craft table. We had 18 all-church events in 2022. These are events like the entertainment night, fall retreat, or nominate a nonprofit, and are in addition to our weekly service, coffee hour, and adult education Zoom groups. During the summer, we shared joined services with Mills Church, as well as Easter, Ash Wednesday and Christmas Eve.

Other all-church events were; a chili supper, egg hunt, writing letters to congress, our One Year Anniversary potluck, honoring our graduates, Kids Kamp, Perfection Free Singing, garden, birdhouse painting, and Frantzich / Robinson concert, and a charming Blessing of the Animals.

We held many food/supply drives, which the congregation generously contributed to, including food for ICA; warm wear, toys and school supplies for Resource West; sandwiches, pillows, hats, and snack bags for Our Savior's Housing; and exit baskets for Sojourner's.

Church Life welcomes new people at any time to join the team. If you have an interest in doing any part of Church Life's jobs, such as preparing communion once in a while, please let Laura Eggert know

We had 30 kids and teen helpers, plus 8 adults at Kids Kamp in August.

We started collecting coins this year for the children of the church to have a small amount of money to give away to organizations that they chose. This year, they used some of the money to make and serve a meal to clients at Our Savior's Housing. In addition, the kids ran bingo at Our Savior's and purchased prizes to give out to everyone.

Growth Task Force

Church Growth Highlights Focused on "Visitors":

We had approximately 23 first time visitors at our worship services in 2022, mostly family of members visiting from out of town.

Follow up views for replays of worship services a week after the service varied from 10 to 40 views. Some have totaled over 90 for the year.

We began the year with 31 subscribers to our online worship and ended the year with 45.

Spirit of Peace `-5- 2022 Annual Report

We began monitoring the "chat" function on our live stream in November.

Kids camp attendance was over 30 per day. Approximately 10-15 visitors.

Our Church Growth Team sent hand-written letters to new Minnetonka residents in June and July welcoming them to the community and inviting them to connect to our website or visit in person.

Timothy Frantzich led us in *Perfection Free Singing* workshops in September and October with attendance over 30 persons each week. About 15-20 visitors per week.

We offered a *Blessing of the Animals* in October and had 1 new visitor, which later proved to be fortuitous when one of our youth rescued her escaped cat one cold Saturday at church.

We hosted a concert entitled "Mississippi River Songs" with Robert Robinson and Timothy Frantzich on November 5. We did extensive advertising of this event in the western suburbs of Minneapolis. About 135 persons attended with over 90 being new visitors.

Budget Narrative

The budgeting process, broadly, consists of:

- 1. Considering our desired operations and ministry, and estimating their financial cost
- 2. Obtaining pledges and by other means estimating giving for 2023
- 3. Considering any imbalance and establishing a strategy to address it.

Special Note: The actual year end numbers received on 4 Jan 2023 indicate about \$15,000 greater in giving than the projection at the time of the final budget proposal. The estimated implication of that change is indicated in the gray boxes below.

2022

As we began our first full calendar year, we had no reliable historical data. The proposed budget was approved with a \$35,000 deficit. The year-end projection shows a \$40,500 deficit, and it is used as a baseline for the 2023 budget.

2023

The proposed 2023 budget has only small adjustments from the 2022 budget, and has a \$44,000 deficit.

The number can be reviewed in several different ways to give more perspective:

- The deficit is about 1/3 of the total budget
- Based on 30 giving households
 - o Expenses are \$4343 per household
 - o Projected giving is \$2878 average per household (\$2373 average of middle 80%)
 - o Projected deficit is \$1465 per household
 - o Projected deficit is equivalent to 15 average giving households (18 middle 80% households)
- St. Paul's has about \$240,000 in cash reserves. These reserves would sustain us
 - o For over five years with a deficit of this amount and no growth
 - For over nine years if we had a net gain of 2 households per year, at which time we would be self-sustaining

Council Motion for presenting the proposed budget to the Congregation:

I move that we recommend the 2023 Budget as discussed and that we announce a strategy for achieving sustainability through growth and informing the congregation about costs per family. Vince will write up a presentation for the Coordinating Council to review via email.
